Health Choice Care Delivers Strong Quality, \$13M in Medicare Savings, and Strategic Expansion for 2026

Miami, FL — Health Choice Care, LLC (HCC), a Federally Qualified Health Center (FQHC) led Accountable Care Organization (ACO) participating in the Medicare Shared Savings Program (MSSP), announced strong quality performance and meaningful cost savings for Performance Year 2024 alongside a significant expansion of its national network for Performance Year 2026.

In 2024, HCC improved care and reduced costs for more than 8,500 Medicare beneficiaries, strengthening care coordination, improving chronic disease management, and increasing preventive screening while delivering meaningful savings to Medicare. These results underscore the power of community-led, data driven care to improve outcomes and affordability.

For 2026, HCC welcomes additional community health centers, expanding the ACO to 28 health centers serving approximately 27,000 beneficiaries across Florida, Hawai'i, Illinois, Missouri, North Carolina, Oregon, Rhode Island, Texas, and Washington, with continued growth anticipated.

“Our FQHC-led model ensures that every dollar saved is reinvested into improving care delivery for the communities we serve,” said Margarita Ollet, Chief Executive Officer of Health Choice Care. “These results highlight the strength of collaboration, data-driven care, and the unwavering commitment of our health center partners to advancing health equity.”
